

Social determinants of health

- Income, wealth, housing, environment, education, life opportunities, inequality impact most on health.
- Unequal health system exacerbates health inequalities. Focus on treatment rather than prevention.




Social determinants of health


- Overall levels of wealth and income are not as important as the **distribution** of wealth and income.
- We have made progress on health (in general),
 BUT little or no progress on reducing health inequalities.

Policy Context

- Council of European Union (Dec. 2011) adopts conclusion "closing health gaps within the EU though concerted action to promote healthy lifestyle behaviours."
- European Public Health Alliance Council conclusion "doesn't go far enough." Critical of over-emphasis on 'downstream' policy solutions instead of addressing 'upstream' issues – social determinants.
- Wilkinson and Pickett The Spirit Level: Why more equal societies almost always do better.

Policy Context

- Programme for Government commitment to free GP care and greater health equity through universal health insurance.
- Your Health is Your Wealth: A Policy Framework for a Healthier Ireland 2012-2020.
- Terms of reference aim to address:
 - Wider determinants of health and health inequalities
 - Chronic disease and lifestyle
 - Inter-sectoral and cross-sectoral approaches at policy and practice level
 - Protection from and responses to public health threats

TASC Submission on new Public Health Strategy

Public health policy should aim to protect the whole population from ill-health; facilitate people to live longer, healthier and more fulfilling lives; and reduce health inequalities by improving the health of the poorest, fastest.



TASC Submission on new Public Health Strategy

- Public health policy should reflect all aspects of people's lives – early years; children and young adults; employment and working conditions; healthy communities; health and wellbeing in old age.
- Provision of high quality, publicly funded and universally accessible public services with a strong focus on preventative measures.



Eliminating Economic and Health Inequalities

- Different **economic model** based on productive activities, job rich, maximising natural advantages.
- Fiscal policy direct impact on income equality.
 Need to equality-proof the budget distributional analysis of proposed budgetary measures.
- Gradual move towards Western European levels of taxation to fund the types of public services we want.
- Increased investment targeted at early childhood education and public health.
- BUT..... we're in a EU/IMF bailout fund!
- AND we still have choices.



Public Health - Focus on Primary Care and Funding on basis of solidarity

- Primary care 'the poor relation.'
- If we get it right, we will make a lot of progress –
 preventative measures, less costly, accessible...
- Financing healthcare
 - What outcomes do we want to achieve?
 - Financing mechanisms designed on the basis of solidarity is the most critical factor.
