## THE PARTICIPATION AND REPRESENTATION OF WOMEN: THE SUCCESSES, GAPS AND CHALLENGES

GOOD AFTERNOON, MY NAME IS SALOME MBUGUA, THE CEO OF AKIDWA, VICE CHAIR OF THE NWCI, I ALSO SEAT ON THE MONITORING GROUP ON 1325 REPRESENTING NWCI.

MY ORGANISATION AKIDWA HAVE BEEN WORKING WITH
MIGRANT WOMEN OF ALL BACKGROUNDS AND OF DIFFERENT
IMMIGRATION STATUS FOR A DECADE. OVER THE YEARS WE
HAVE SUPPORTED WOMEN THAT HAVE ENDED UP IN IRELAND
AS PROGRAMME REFUGEES AND WOMEN SEEKING
PROTECTION- ASYLUM SEEKERS FROM SUDAN, CONGO,
SOMALIA, RWANDA, ROMANIA, RUSSIA JUST TO NAME A FEW.
WHILE THE BASIC NEEDS OF MOST OF THESE WOMEN MIGHT
HAVE BEEN MET IN IRELAND AND WHILE THEY MAY FEEL
SECURE, THEIR PSYCHOLOGICAL AND SOCIAL WELL-BEING HAS
NOT BEEN MET, MAJORITY CONTINUE TO STRUGGLE WITH
TRAUMA,

THERE IS DEFINITELY GAPS AND LACK OF SPECIALISED
SUPPORT- OTHER CHALLENGES SUCH AS, LANGUAGE BARRIER
AND LACK OF SUPPORT NETWORKS.

SINCE 2008 AKIDWA HAS BEEN ADVOCATING FOR THE IMPLEMENTATION OF ASYLUM GENDER GUIDELINES-RECOGNISE AND CONSIDER GENDER SPECIFIC HARM- 1951 UN DEFINITION/QUALIFY FOR REFUGEE DO NOT IN COOPERATE THE GENDER SPECIFIC HARSH, RAPE DURING WAR, FGM, SEXUAL ORIENTATION, AKIDWA 2013 STATICS ON FGM INDICATE THERE ARE 3780 WOMEN LIVING IN IRELAND THAT HAVE UNDERGONE FGM, WHILE WE ARE HAPPY TO HAVE THE LAW PROHIBITING THE PRACTICE IN IRELAND THERE STILL NO REFERRAL PATH OR SUPPORT MECHANISM IN PLACE TO ADDRESS NEEDS OF THESE WOMEN

DEPORTATION/ RETURN OF WOMEN TO WAR TORN COUNTRIES

ON WORLD REFUGEE DAY DEPORATION WERE CARRIED OUT

TO D.R.CONGO, WOMAN WRE AMONG THOSE THAT WERE

DEPORTED, THESE HAS BEEN WORRYING, ALSO THE WAY THESE

DEPORTATIONS ARE CARRIED OUT TEND TO BE MORE

TRAUMATISING TO WOMEN, THEY ACTUALLY LEAVE MORE

TRAUMATISED THAN THEY CAME.

IN 2012 ORAC INVITED AKIDWA TO MAKE A SUBMISSION FOR DOMESTIC GENDER GUIDELINE, HOWEVER WE ARE YET TO SEE THE FINAL DRAFT.
